Where complete results were received from a competition, including entries not receiving a ribbon, the designation AS = Also Shown, the entry having competed without receiving a prize/ribbon. While we make every effort to avoid mistakes, we assume no liability to anyone for errors. Significant errors should be called to our attention by email, to saddlebred@asha.net; once the information is checked/verified, corrections will be made in the normal course of business. Competition records prior to 1990 may be incomplete. For shows held before 1984, horses may have been showing against non-registered Saddlebreds.
